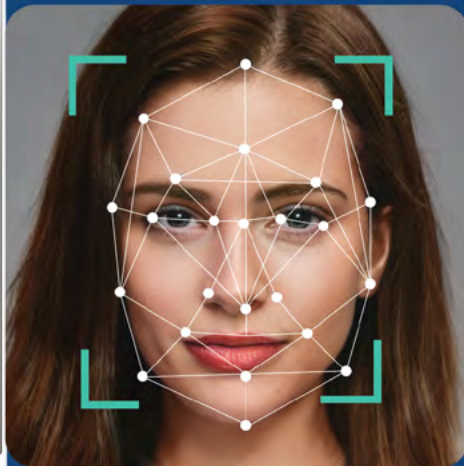

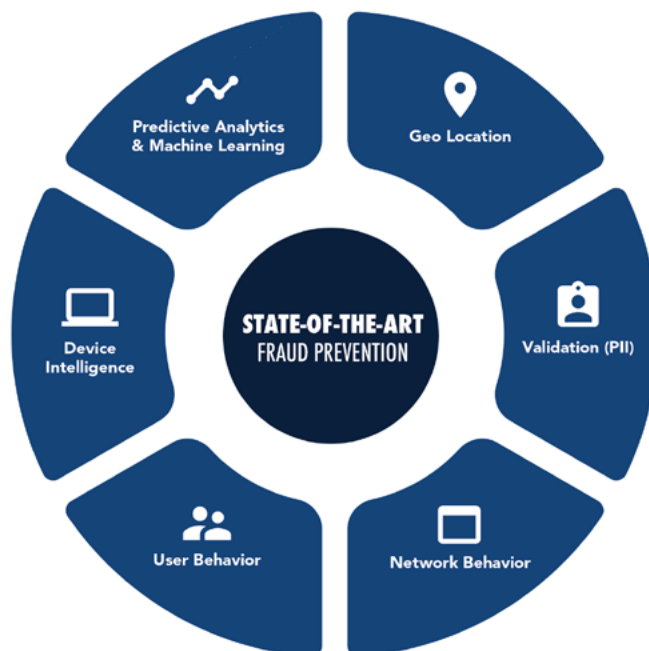

# Going Beyond The Basics To Mitigate Risk

## Predictive Analytics & Machine Learning

Linear and nonlinear models trained with collective intelligence accurately predict good and risky identities with fully human readable explanations that justify decisions.

## Device Intelligence

Device fingerprint checks to uniquely identify the devices being used to sign up and stop bots as well as previously known fraudulent actors and risky devices.

## User Behavior

Passive biometrics measures to detect bots and verify cognitive behaviors (e.g. copying and pasting into a sign up form vs. directly filling out the form) on the device that identify the human actor on the device.

## Network Behavior

Measures to compare velocity of each piece of user information as well as compare each signup for anomalies.

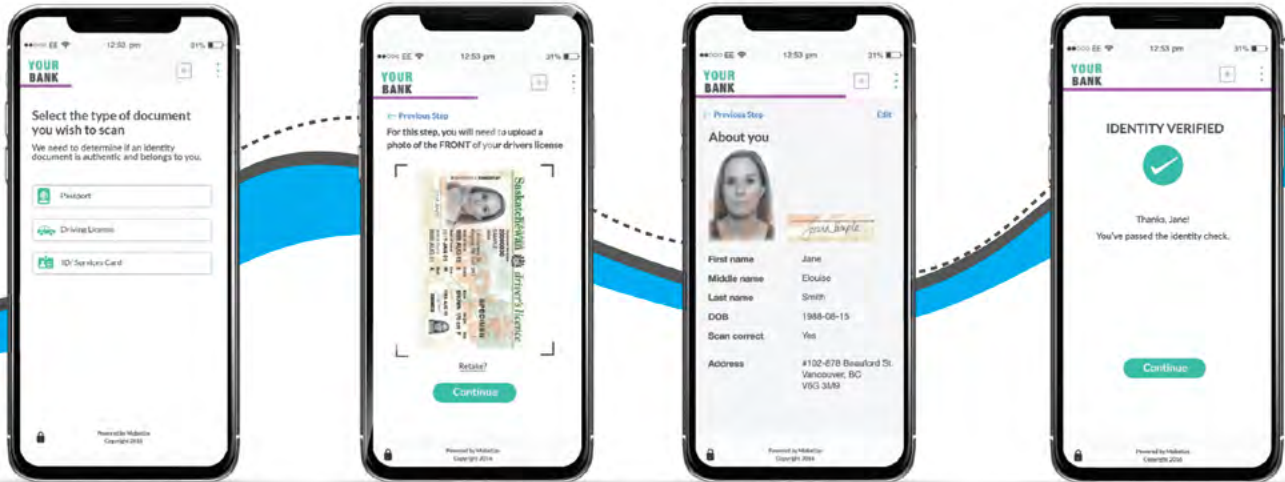
## Validation (PII)

Validates and verifies customer's personal information including attributes as well as documents to filter synthetic and third-party fraud. It also correlates all the supplied information with the user's name and search global watchlists to stop terrorists and money laundering for KYC compliance.

## Geo Location

Checks for known spammer IP addresses and verifies repeat customers known locations while filtering out spammers and other bad actors.

# Real Time ID & Document Verification Without Manual Intervention



**1** At this stage, the customer uploads an image of their identity document. This could be a passport, driving license or a provincial ID/ Services card.

**2** A photo of the ID document is taken and the document is analyzed for fraud.

**3** The document is crossreferenced using advanced OCR extraction and printed PII comparison from the document .

**4** Document identity is passed or failed instantly with no manual intervention.
